



For training purposes only, use the following information to access the training location for the Testing Irregularities Web Application System

The web address for the training location is <https://t1pe.doe.virginia.gov/ssws/login.page.do>

Note

This is a different web address than for the “live” application. Only enter fictitious irregularity information at this web address. All “live” testing irregularities must be entered in the web address shown in the User’s Guide.

The following login information is available to all divisions in Virginia. Multiple people may be logged in at the same time using the same login information. All information entered into the training location will be visible by others across the state using the login information below. The login information will gain you access to a false school division and schools.

The User Name and Password for a School Test Coordinator (STC) is:

User Name: stc999
Password: stcpass999

The User Name and Password for a Division Director of Testing (DDOT) is:

User Name: ddot999
Password: ddotpass999

Once in the training location, refer to the *User’s Guide for Testing Irregularities Web Application System* (available at: <http://www.doe.virginia.gov/VDOE/Assessment/TestIrregularity/TestIrregUserGuide.pdf>) for information regarding system functionality.

In order to become familiar with the functionality of the Testing Irregularities Web Application System, be sure to use the information from the table provided (on the following page) in the training location. An irregularity cannot be added to the training location without entering the correct information from the table. The column headers in the table match the fields on the Add Irregularity and Edit Irregularity screens. Be sure that the information provided on an irregularity screen is consistent with the information in one of the rows from the table. For purposes of training, the fall administration information will be used.

Note

Be sure to select “2004” from the Admin Year field when entering information for the fall administration.
