The *No Child Left Behind Act of 2001* (NCLB), requires states to monitor school divisions and subgrantees for compliance in certain program areas. As a result of this requirement, school divisions are monitored on a five-year cycle in Virginia. On-site federal program monitoring visits include the following federal programs: Title I, Part A, Improving Basic Programs; Title III, Part A, Language Instruction for Limited English Proficient and Immigrant Students; and Title X, Part C, Subtitle B, McKinney-Vento Homeless Education. Title I, Part D, Subpart 2, Prevention and Intervention for Neglected and Delinquent Children and Youth is also included in the monitoring visit if the school division receives funds under this title. In addition, Title I, Part D, Subpart 1, Prevention and Intervention for Neglected and Delinquent Children and Youth for state agencies is monitored on a five-year cycle. Monitoring for these programs includes on-site visits to facilities.
