The Advisory Board on Teacher Education and Licensure's annual report on the Board of Education.	The board accepted the report, which included five initiatives: recommended guidelines for implementing Option 4-Division Superintendent License; recommendations to enhance the phonic instruction proficiency of pre-service and in-service teachers; summer 2003 pilot project to offer Praxis I to high school graduates interested in pursuing a teaching career, a plan to conduct match, validation and standard-setting studies of Praxis II assessments in special education; and a plan to study the use of the SAT as an alternative for Praxis I.
