A baccalaureate degree is the minimum requirement for an educational license in Virginia. If you attended a college/university outside of the United States of America, you will need to write to one of the agencies listed below. You must obtain an evaluation of your credentials (including a listing of the courses completed and the semester hour equivalent for each course) and a statement regarding the equivalency of your program of study to the four-year baccalaureate degree. In lieu of an official transcript from the foreign institution you attended, the Department of Education will accept the statement. (Please refer to the "Routes to Licensure in Virginia" on the Department of Education's Web site, [www.doe.virginia.gov](http://www.doe.virginia.gov), for additional information on the alternate route to licensure). Your complete application packet must be submitted by an employing Virginia school division, employing Virginia nonpublic school, or the Virginia college/university where you completed an approved teacher preparation program.
