Final reimbursement requests must be submitted by November 15, 2016.

**Terms and Conditions:** The grant is subject to the provisions of Title I (P.L.107-110) and Title XIV of the ESEA as amended and *General Education Provisions Act* (GEPA), as applicable. The grant is also subject to Title I regulations in the Code of Federal Regulations (CFR) Part 200 and Education Department General Administrative Regulations (EDGAR) in Title 34 of the *Code of the Federal Regulations* (CFR) Parts 76 (except for 76.650-76.662 participation of students enrolled in private schools), 77.80.81.82. and 85.
