A question was asked about the Board's contract with a vendor to assist with the review of the SOQ. Mrs. Anne Wescott, Assistant Superintendent of Policy and Communications, explained that in order to benefit from research and analysis from an objective third party, a contract was in process with a vendor to assist with data collection and the preparation of the report.

Board member, K. Rob Krupica, noted his appreciation for the comments that were received, but stated that the Board needs more specific recommendations regarding what needs to be changed and why.
