SUBJECT: CARES Act Grants Ending September 30, 2022

This notification is provided to school divisions due to large grant balances remaining in federal grants awarded under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. Federal CARES Act grant awards will end on September 30, 2022. All funds under the awards below must be encumbered by September 30, 2022. The final approved reimbursement request must be received by the Virginia Department of Education no later than November 15, 2022, unless you have been provided with a reimbursement request due date that is sooner than this date. The Spend-Down Calendar available in the Online Management of Education Grant Awards (OMEGA) system will reflect current balances.
