2015 Multidivision Online Provider (MOP) Report to the Board of Education

- Assessment data for students who took the Virginia Standards of Learning subject area tests, the Virginia Modified Achievement Standards Test, Virginia Alternative Assessment, Virginia Substitute Evaluation, and Virginia Grade Level Alternative were collected. The DOE Student Record Collection shows the **participation rates** for all students who were required to take one or more of these assessments and who took a virtual course from an approved provider
 - English: 98.11%
 - Mathematics: 94.73%
 - Science: 95.62%
 - History: 96.65%

2015 Multidivision Online Provider (MOP) Report to the Board of Education

- Of the 1,365 courses currently approved for offering, including electives added during the year, 616 are SOL.
 - $616/1,365 = 45\%$

2015 Multidivision Online Provider (MOP) Report to the Board of Education

The Department of Education requested all multidivision online providers send program participants links to a **parent survey**.

- 78 survey responses were received from 6 of the 12 providers who offered instruction during the 2014-15 school year.
- 75 were from parents, 3 were from mentors, and 0 were from students, administrators, mentors, or learning coaches.
